

# July 2021 – Newsletter #6

#### February Committee Meeting

The committee held a Zoom meeting in February to discuss the 2021/22 Operational Plan and Budget^ with official details of the Wild Dog Action Plan 2 funding for the CRBA moving into the new year. This was welcome news which allowed the budget to continue eight LPMT contractors each for 200 days, along with the Spring community baiting.

Discussions also included project updates, LPMT reviews and planning of the LFH project planned for March 2021.

^ Significant changes are required to this document due to announcements by DPIRD on the reduction of funding (as outlined in the Financial Update provided to all members in July 2021)

#### June Committee Meeting

#### Chair Justin Steadman Update from Committee Meeting:

Justin Steadman provided the committee with an update on what has been happening with DPIRD the last few weeks, with the Department showing 'true colours. There are significant changes occurring due to the objections to the Pastoral Lease Rents that were adopted this year (2020/21). We are unsure at this stage the impact these objections and the expected additional ones before 30<sup>th</sup> June 2021 will have on Pastoral RBGs. We do know that dependant on the area will depend on the impact.

RBGs have pointed out to DPIRD that we didn't cause the issue and it is something that they or the state need to fix. DPIRD aren't able to tell Pastoral RBGs what affect it will have on each group.

Justin said that we are stuck with the budget for 2021/22 until we have confirmation on what impact these changes will have on income for 2021/22 and the impact changes will have on already spent funds in 2020/21.

DPIRD sent Pastoral RBGs an 'update' after our meeting last week which has received direct responses from not only the CRBA (myself) but also the chair of the MRBA.

If DPIRD do not come to the party to support RBGs through this process we will need to assess how we move forward into the future, we are in limbo however until the real outcome is known.

These changes also impact the promised funding from Shire of Upper Gascoyne as they (all Local Shires) are also impacted by the objections to the Pastoral Lease Rents. SUG advised Krystie that they should know Wednesday 23<sup>rd</sup> June which way council will vote with regards to their expected shortfalls.

In summary:

Justin also said that Pastoral RBG Chairs are in the process of drafting a letter directly to the Minister advising of the meeting with DPIRD and around liability being a state responsibility.

# Summary of July Financial Update from Chair

# What is the financial impact to the CRBA for 2021/22?

There is an overall blow to the CRBA budget of \$630,994 between monies to be paid back and loss in operational income for this year. Over and above this, the Shire of Upper Gascoyne has also cut their contribution to activities across their shire by \$70,000.


A breakdown of this is as follows:

- Prior to consultation of the rates for the 2020/21 year the Declared Pest Rate (DPR) was decreased to reflect the significant
  increase in VEN across the CRBA area. It went from 5.963c to 3.573c (meaning our total operating budget was the same as
  planned and didn't increase with these VEN increases).
- According to initial figures received from DPIRD late last week the CRBA is looking to have to pay back/credit those who objected a total of <u>\$291,552</u> for the 2020/21 year, these funds have already been spent.
- Due to the decrease in VEN and our now reduced cents in the dollar DPR the operating budget for the CRBA for the 2021/22 year is now 55% lower than planned being only \$352,249.
- DPIRD will also be using the funds held in the CRBA Declared Pest Account (DPA) which is formed from outstanding rates paid and has been available for us to draw down additional funds each year for operations.
- Based on our submitted operational plan spending we are short over <u>\$400,000.</u>


The committee will now work on a total revision of the Operational Plan and budget inline with the massive reduction in funding. Once this has been submitted to DPIRD a copy will be provided to all members.

# Landholder Data

The Committee would like to thank those members who have provided responses to our data surveys. We have received the following data to date for the 2020/21 year, a big improvement on information obtained for the previous years.



Responses for January – March 2021 is based on responses from 31 landholders.



April – June 2021 is based on responses from 10 landholders.



#### Wild Dog Control for 2020/21

LPMT data for 2020/21 shows that numbers have remained consistent across the region for the past 12 months, in fact some areas have observed a significant increase in number of animals controlled. Not only by the LPMTs but by landholders.

Across the entire CRBA region a total of **504** dogs were controlled by LPMTs with more than **81** controlled by landholders.



LPMTs alone, will not control pests within the region.

# Coral Coast Cactus

After our LPMT gathering in mid-2020, each contractor has been monitoring and reporting back any weed infestations they observe on the properties they cover. Through these observations and with assistance from Tim Meecham we have been able to collect Cochineal Bugs from Quobba Station and distribute them to four other infestations within the CRBA region.

#### Landholder/Manager Training Program

With thanks to Australian Wool Industry (AWI) Funding the CRBA will be running a series of training sessions to assist all pastoralists and managers.

Australian Wool Innovation Limited Two training sessions took place in March 2021, one in Carnarvon and the other in the Murchison. Great attendance was recorded at both. There are now an additional 16 members of the community who are able to assist at community bait racks. A great outcome!









A special thanks goes out to **Grot** from Murchison Settlement who stepped in and helped on the day. Not sure the day would have run as smoothly had she not been there to assist.



We are hoping to hold a third training sessions before the end of 2021 for those landholders who couldn't make the last two. #### **Community Baiting - Bait Meat Freezers**

Due to the current financial constraints, outlined to members in the Financial Update emailed on the 27<sup>th</sup> July 2021 no bait meat will be ordered for the normal Community Baiting programs in 2021/22 unless alternative funding can be secured.

With this in mind and the current budget implications faced by the CRBA there is currently NO bait meat available for individual landholder operations. Should you wish to access any meat from the three CRBA freezers, please call and discuss with Krystie Bremer to ensure there is bait meat free for your usage.

The Committee would again like to thank the Shires of Carnarvon, Murchison, and Upper Gascoyne for providing the location and ongoing running costs of these freezers.



#### Rangelands NRM – LFH Control for Ningaloo World Heritage Region

The second phase of the 2020/21 program took place in March across the North Carnarvon/Upper Gascoyne and across the Murchison. It was another well-run program, which had great results.

Across the entire area covered a total of 612 animals were controlled. Including ferrying time, a total of 54.8 hours were utilised. There were 3 wild dogs controlled and 609 LFH. A very successful and financially viable program.





#### WONS – Mesquite Control

management program The much welcomed wet started to 2021 has seen progress on the WONS project stalled due to running rivers and wet access roads. 2022 is the final year for this project and we are on track to have provided initial and follow up treatment to not only those properties initially included in the project but additional properties.

#### DPIRD Wild Dog Research – Tracey Kreplins

Tracey Kreplins has a number of research programs planned across the CRBA during the 2021/22 year. Those being:

- Continuing to work with our 8 LPMT contractors to collect DNA samples. This work has shown some interesting results, not just within our region but with animals controlled in the CRBA being related to animals as far south as northern agricultural zone.
- Tracey is working alongside Mat Cole to catch and collar wild dogs to see the correlation between movements of stock and dogs. This is proving difficult and they are planning to try again in October/November this year. These collars will in no way stop Mat from undertaking control work on the properties involved but it is hoped that some data is collected prior to them being controlled.
- The Ceres tags have arrived to track cattle alongside wild dogs. These will be attached to the cattle when mustering starts.



- There are three properties within the SUG involved in a bait trial. This trial has seen field cameras put out already with a bait run happening late August (it has been delayed multiple times due to rain). These baits will have small GPS trackers put into them, with them being tracked to see if they move, how far and by what animals.
- Lastly a controlled CPE project will also commence with August. The point of this trial is to see the effectiveness of the chemical over time and will take place over the next 12 months.
